What is GRI?

- The Global Reporting Initiative (GRI) was founded in 1997 by CERES in partnership with the United Nations Environmental Program (UNEP).
- Using a participative process, GRI develops guidelines for sustainability reporting for major companies, SMEs, governments and NGOs around the world.
- The framework is based on defined principles and indicators, which help organizations improve their economic, ecological and social performance and provide structured and transparent reporting on their progress.
- Reporting according to the GRI Standards provides decision-makers with the information needed to take actions that lead to a sustainable economy.

Two-day training for beginners
